Spanish and British staff at the Brampton colony

This spreadsheet has been largely compiled from correspondence in the Roberts archive at Carlisle Archive Centre. The information has been extracted from throughout the DROB collection, but in particular from a folder labelled 'Spanish Relief - Staff' (DROB Accsn H15988 Box 3). As well as information on those employed, the correspondence includes letters in which people are recommended for employment as well as letters asking for employment. It is not always possible to know whether these people were employed so unless there is other evidence they have been omitted from this spreadsheet.

Unless statements are referenced as coming from elsewhere, all information comes from the DROB archive at Carlisle Archive Centre.

Sent to Ambleside home Oct 1937-Feb1938. Letter of 20 Nov 1937 from Charles Roberts to BCC says 'good reports' of Fröhlich at Ambleside. Referred to by Lolita as a member of staff at Brampton April 1938.
Mrs Winifred Nicholson	Art teacher	Daughter of Charles and Cecilia Roberts. Named by Alfonso Ruiz López as teacher of painting in watercolour and oils in his testimony in Benjamin, <i>Recuerdos</i> , p.144-7.
Harry Herrington	Singing teacher	Named by Alfonso Ruiz López as teacher of singing in his testimony in Benjamin, <i>Recuerdos</i> , p.144-7. Remembered by Ma. Carmen Cid Santibañez as playing the piano and living in Stanwix, Carlisle. He remained in contact with Carmen's family and later worked for the AA (pers.comm. from Ma. Carmen Cid Santibañez, 4 May 2022).
Mr Dobinson		Arrived at Brampton October 1937. Listed by Lady Cecilia as staff member 22/10/37. 18/11/37 letter from Lady Cecilia to BCC says Dobinson 'who has helped us for about a month' is leaving.
Mr St John H.M. Jones	Teacher?	Arrived in Brampton July 1937? Age 38. He had taught in Spain. Listed by Lady Cecilia as staff member 22/10/37. 18/11/37 letter from Lady Cecilia saying that Mr Jones is 'on the verge of a nervous breakdown' and is leaving to recover.
J. Dudley Pank	Joint Administrator (until before 22/3/39).	15 Nov 1938 letter from CH Roberts in which he describes Pank as 'a new English warden we have recently appointed and a very efficient organiser'. Nov 1938 - this is how he calls himself when signing off letters. Letter from Pank to Papps (15/3/39) says that during past 21 months 'children here are wild unruly' and 'definitely deteriorated during last 21 months'. Other staff have 'sabotaged' such discipline as I have tried to enforce' over last 5.5 months. Letter from CHR to Miss Newbigin (22/3/39) says Mr Pank has left at request of committee, and Mr Joseph Ordeig now in sole charge.

Richard Papps	Hon. Sec. Spanish Relief Committee	2/7/37 Miss Quinlan inspected on behalf of Ministry of Health - refers to Papps as 'responsible person'. (TNA: MH57/323) In correspondence with Cumberland County Council re petty vandalism autumn 1937 (Carlisle Archive centre: C/C/4/5/57). Referred to by Lolita in Feb 1938. Referred to by Mr Dawson 31/1/39 and 10/2/39.
Ana		Referred to by Lolita as a member of staff April 1938.
Miss Winifred Thomas	Sub-matron	Arrived at Brampton June 1937. Age 42. A Spanish speaker, fluent in 'Basque dialect'. Had worked in Spanish schools. Listed by Lady Cecilia as Sub-matron 22/10/37. Referred to by Lolita as a member of staff April 1938.
Walter Hobson	Administrator of adoption scheme at Brampton colony from September 1938	Hobson took over Brampton adoptions from BCC acting through Charles and Cecilia Roberts as the adoption scheme grew in size (Hobson letter of 11/9/38).
Mrs Amy Hersant	Matron	Arrived at Brampton June 1937. Age 49. A Spanish speaker who had lived and taught in Spain. Matron from June 1937 for a few weeks but soon left overwhelmed by the role. Was Matron when Miss Quinlan (Min of Health inspector) visited 2/7/37. Quinlan refers to tension between Matron 'who is a very capable woman' and Lady Roberts 'who is said to interfere all the time'. (TNA: MH57/323)
Miss Lois Newman SRN	Matron	Arrived Brampton 21 July 1937. Replaced Mrs Hersant but only stayed a short time as she discovered that the role required a Housekeeper rather than a nurse. A Spanish speaker. Left during August 1937. 20/8/37 letter from CHR to BCC refers to her.
Miss Crawe	Housekeeper	Arrived at Brampton end August 1937, following letter from Charles Roberts asking her to become Matron 18/8/37. Scots. Listed by Lady Cecilia as Matron 22/10/37. Had a nervous breakdown during 1937 and left. Returned in December 1937 on basis that she could have some time off each day (see letter 6/12/37). Referred to by Lolita as a member of staff April 1938.
Miss Walker	Cook	Cook from June 1937.
Mrs Lawrence	Cook	Referred to in letter from BCC to Mr Papps 3/8/37. She left 9 August 1937.

Mr Dawson	Cook	15/3/39 letter from Pank to Papps described Dawson as an asset to the hostel - good at budgeting; also a lover of efficiency and discipline. Unpopular with other staff. 15/3/39 letter from Dawson to Committee says that he has had help from his wife and daughter in management of kitchen - but food has been stolen and children continually asking for more. Also staff dissatisfied with quality.
Dr Nelson	Doctor	Miss Quinlan (MOH inspector) states he visits daily (2/7/37) (TNA: MH57/323).
Dr Hall	Doctor	From Bridge of Allan. May have come for first fortnight in June 1937 but correspondence does not make it clear.
